Dear Ministers, Dear Ambassadors,

We, the undersigned, welcome the aim of the draft Regulation on preventing the dissemination of terrorist content online (the 'Proposal') to improve the effectiveness of the fight against such content. Terrorist content is unequivocally unacceptable offline and online, and positive results have been achieved from stakeholders' voluntary initiatives, as acknowledged by the European Commission.

Over the past few months and with the benefit of experience, we have suggested ways to amend this Proposal to ensure that the approach taken is effective, proportionate and compliant with the European Charter of Fundamental Rights. As the European Parliament has only recently started its review of the Proposal, we regret the recent endorsement by COREPER and urge the European Council to take the necessary time to thoughtfully address these outstanding concerns.

In particular, we are concerned about the "one-size-fits-all" approach of the Proposal that does not recognize the reality that different types of services may require individual responses. We would recommend the adoption of a narrower scope, reduced to hosting services where there is a real risk of propagation of terrorist content - thereby excluding, for instance, cloud infrastructure service providers that do not have access to customer content and cloud providers (including business to business cloud services) that do not share content to the

general public. Some of the Proposal's requirements, e.g. the one-hour turnaround time for the takedown of content, present also operational challenges for SMEs.

We also strongly recommend the deletion of the provisions requiring hosting service providers to monitor and filter data for the removal of terrorist content across the Internet. This requirement, coupled with unworkable deadlines and high penalties, would lead to abundant removals by strongly incentivising hosting service providers to suppress potentially legal content. The automatic and proactive removal of terrorist content across the Internet might also hamper some investigations of terrorist organisations by law enforcement agencies. Therefore, cooperation between law enforcement agencies and halting terrorist content production at the source should also be addressed.

To conclude, the clarification of some definitions is also crucial for achieving the aim of this Proposal. 'Competent Authorities' and their powers should be clearly and narrowly defined. This is necessary when fundamental rights such as freedom of expression and privacy are at stake. The definition of terrorist content should also be reconciled with the recent Directive 2017/541 on combating terrorism, with clear exceptions for educational, documentary, scientific or artistic content.

We hope to have the opportunity to continue our dialogue with the Council in the upcoming months.
